

Disability Assessment Medicine is concerned with an individuals' function in relation to medical conditions.

- Functional Assessors are specialist practitioners in disability assessment
- Disability assessment medicine takes note of diagnoses as these may give some indication regarding possible functional impact, however, diagnosis is not the primary focus
- This role does not require you to diagnose, prescribe, or take responsibility for the ongoing treatment of the claimants that you assess.
- Your responsibility is to write a report that accurately reflects their level of disability, in accordance with current legislation

CAREERS FOR FUNCTIONAL ASSESSORS IN DISABILITY ASSESSSMENT MEDICINE

If you are making your first steps away from clinical medicine, and are exploring other options, then working as a functional assessor may suit you. It may give you an insight into a variety of different areas including the DWP and may be an interesting role for those who are considering pursuing a career in Occupational Medicine. There are options for career progression – you can become a senior assessor, where your role will involve auditing cases and training, and you can be trained to assess for other specialities.

What skills do I need to work as a functional assessor?

- Excellent communication and interpersonal skills
- Good time management
- Enthusiasm about career development
- Strong written skills
- A non-judgemental nature

What are the pros of the role?

- Exposure to a variety of different clinical areas, conditions, and assessment types
- Excellent career progression opportunities
- No physical demands that other healthcare jobs may have
- Flexibility
