The post is based on the Raigmore Hospital site. Raigmore Hospital is a modern district general hospital with approximately 500 beds which serves a catchment area of almost 10,000 square miles covering the entire Scottish Highlands, and a catchment population of c 250,000 (350,000 for tertiary care). Together with one other Consultant colleague and a speciality trainee, clinical duties will include management referrals, self referrals, health surveillance, ill health retirement advice, and post job offer health assessments. As well as providing occupational health services to NHS Highland staff, a broad range of external work is undertaken on a commercial basis with other employers and through sub contract arrangements with other private and NHS occupational health providers.

Applicants must hold full Registration with a license to practise with the GMC and be on the GMC's Specialist Register or be within 6 months of the anticipated award of a CCT at the time of interview.
