## **Role includes exposure prone procedures (EPP)/ Renal Dialysis (RD)**

**EPP:** invasive procedures where there is a risk that injury to the worker may result in exposure of the patient's open tissues to the blood of the worker. These include procedures where the worker's gloved hands may be in contact with sharp instruments, needle tips or sharp tissues (e.g. spicules of bone or teeth) inside a patient's open body cavity, wound or confined anatomical space where the hands or fingertips may not be completely visible at all times.

Taking blood (venepuncture), setting up and maintaining IV lines, incision of external abscesses and simple endoscopic procedures are <u>not</u> considered EPP activities.

RD: undertaking haemodialysis or haemofiltration i.e. dialysis unit/ICU including renal nurses.

X Role is patient facing and/or handling clinical specimens (NON EPP/RD)
 Patient facing: clinical roles (doctors, nurses, allied health), porters, cleaning staff, catering
 etc. Any role with direct contact with patients.

**Handling clinical specimens:** roles which involve the taking, transporting and testing of clinical specimens.

Role is NON-patient facing and does not involve handling clinical specimens: office based staff including offices within clinical areas.

Role involves food handling: only those involved in producing, preparing and handling food.

Role involves rotation: only those in a clinical role that includes rotating to clinical areas identified as an increased risk of exposure to Tuberculosis (TB) – Emergency Department, Acute Medicine, Critical Care, Infectious Diseases, Respiratory Medicine, TB/Chest Clinic, Theatres, Medical Admissions Ward, Microbiology and Mortuary.

**Role involves contact with:** women in the last month of pregnancy and/or young infants under 3 months of age.

**Role involves working/rotating into Sexual Health or identified High Consequence Infectious Disease (HCID) areas:** Paediatric Intensive Care, Paediatric Infectious Diseases, Adult Infectious Diseases, Rapid Response Team, Hillyers Ward, Adult Intensive Care.
