- Ghana is on the West Coast of Africa with a population of 32m.
- Number 1 Gold producer in Africa with over 16 major mining operating companies (Minerals Commission).
- The mining sector is one of Ghana's biggest contributors to the Gross Domestic Product (GDP), contributing 5.0% as of the end of 2021 (2021 Mining Sector Report).
- There are 2 major mining sub-industries
 - Large scale AngloGold Ashanti, Goldfields, Newmont, Asante Mine, etc
 - Small Scale Licensed and unlicensed
- Currently, there are over 3,000 registered small-scale mining groups and 90 Mine Support service companies (Minerals Commission).
 - Heavy emphasis on local content

Outsourcing

- Goldfields, Newmont, Persus, Akyempim Mines
- Majority of mine support services companies eg E&P, AMAX, AUMS, Orica, Maxam, etc

Hybrid


- Managed as a semi-autonomous entity. Receives financial support from the mother company



Occupational Medicine

- Medical Surveillance entry, periodic, exit.
- Currently no regulations requiring statutory health surveillance for mine workers in respect of specific health hazards such as lead, hazardous chemical substances (COSHH), Vibration, Ionizing radiation, Noise
- Most large-scale mining companies are compliant with regulatory requirements for medical examinations.
- Medical Board for the mining industry
 - Occupational disease diagnosis (Medical decision-makers)
 - Disability Assessment for workmen's compensation (Workmen's Compensation Law 1987)
 - Medical Retirement (occupational/non-occupational)

Occupational hygiene

- Most large-scale mining companies have occupational hygiene units
- Few trained occ hygiene specialists in the mining industry. Mostly technicians who have learned on the job and have basic-level training.
- Advise on control measures but mostly PPEs
- Other areas such as ergonomics, air-borne pollutants (welding fumes, DPMs, lead)
 - First ergonomic assessment done by AGA-Iduapriem Mine leading to implementation of controls.
 - Health CCVs AGA
 - Baseline RA + review

Employee Wellbeing

- Some companies have well-being units and have appointed well-being officers
- Wellness programs focusing on physical health and lifestyle disease management.
- Employee Mental Wellbeing Programs
 - Outsourced to external providers (clinical psychologists)
 - Work and non-work-related factors contribute to employee mental health.
- Ghana Chamber of Mines has played a key role
 - Committee on mental health draft policy and procedures for mining companies and for companies to report quarterly to the chamber on the implementation of mental health policies.

Community Health

- As part of corporate social responsibility.
- The company medical doctor liaises with key stakeholders in the public health directorate to understand the needs of the health sector and advise the company on which health projects to prioritize.
- Community health is part of key corporate sustainability initiatives to ensure that communities are better off and to mitigate community health risks from mining.

Community health

- Medical Outreach Programs
 - Health screening (HIV, hypertension, Diabetes, prostate, cervical cancers, breast cancers)
 - Medical care (mobile clinics)
- Health System Strengthening
 - Building medical facilities in neighboring communities
 - Donation of medical equipment, medications and consumables
 - National health insurance registration
 - Malaria control program IRS, Larviciding, bed nets
- Women health
 - Menstrual hygiene program
 - Breast and cervical cancer screening
